Windham Township Board of Trustees met for regular session on May 7, 2020 at 6PM, Trustees Brian Miller, Rich Gano, Dan Burns and Fiscal Officer Casey M Timmons are present. All board members received their monthly financial packets.

5-1-2020

Rich Gano moved to approve April minutes, Brian Miller seconded, all voting yes, motion carried.

5-2-2020

Rich Gano moved to approve expenditures, Brian Miller seconded, all voting yes motion carried.

Guest:

Debbie Blewitt from the Village of Windham was a guest. She is asking the township trustees to share the cost of the Library located within the RFC. The quarterly rent is \$2,659.63. Village pays 70% and Library pays 30%. There was some discussion about the rent and possibly obtaining other local locations owned by the Village. At this time, the conversation is tabled, and no discussion was made.
